Academic Decathlon competed and won 38 individual medals! 2nd place in our division. Mock Trial also competing, 4 rounds of competition, we won 1 out of 4 rounds. II. Approval of Minutes from Previous SSC Meeting Motion to approve by Mahfood, seconded by Desfosses. Roll call vote taken and motion passed.

III. WASC Visitation: Parent Group- Mrs. Inchcliff presented regarding the upcoming WASC visit on Feb 21-24th. Evaluates our school, this year will be all virtual, that verifies our report and what we do at our school Parents on SSC are being asked to attend and meet with the visiting committee on Sunday February 21st at 4pm. Parents have been involved in our report but does look different this year, parents have been asked through ELAC, SSC and parent surveys. Would like parents on SSC to complete a survey to better prepare them for the meeting with the committee. Committee is made up of 5 educators from all over California. This is our full 6 year visit. Mrs. Inchcliff reviewed the areas of growth that CHS needed to focus on and the ones that were added during the 2017 Mid-Cycle visit. After the visit/end of visit they will provide us with a report and let us know if we have received a 3 or 6 year review. Findings will then be presented to the WASC board before their recommendation is final.

IV. FEV Tutor, Proposal -Proposal was sent out \$25 an hour and about 1000 hours and they do roll over. Motion to engage FEV Tutors motioned by Spreng, seconded by Mahfood. Roll call vote taken and motion carries.

V. SPSA: Possible budget transfers- None at this time.

VI. 2021-2022 Safety Plan - Safety plan is a requirement. Our first goal is to decrease our suspensions from drugs and alcohol related offenses. The other goal is to decrease violence and inappropriate interactions between gang affiliated students. All staff have been provided with a folder of a checklist, phone numbers, printed rosters, room assignments. Copies are also available in the Main Office. NaviGate Prepared is used by staff to use as a means of responding to emergencies. Reunification Command Flowchart was shared and was noted that it is flexible based on the emergency. Reunification location was moved to Memorial Bowl as evacuation. We have Plan A which busses will come in on Cherry Lane to pick up students along with parents coming to gym to pick up their students. Staff would help release students to parents. Plan B would be using the normal pick up location for busses if we know ahead of time. Emergency supplies were purchased such as radios, water, blankets, gurneys, and other items. The Auto Shop and Ag Mechanics also have reunification and evacuation plans including transportation plans as well. ELP will also need access or their own account to the same emergency software. Will need to set up those accounts for the ELP teachers.

VII. Adjournment- Motion to adjourn by Spreng, seconded by Arce. Roll call vote taken and passed. Meeting adjourned at 5:40
